Kim Jung-Un, Evil Despot? Remember Donald, He's Just a Boy

Recent side by side images of heads of state provide a simplistic juxtaposition and contribute to a confusion of capability and a personification of issues and conditions. Application of Stratified Systems Theory¹ and Requisite Organization² principles would suggest the possibility, nay, the likelihood, of significant differences in information processing capability with the inevitable effect on the management and operation of a state. It is understood that complexity of information processing matures reliably with age, regardless of education and life circumstances.³ Arguably the lower the capability, the greater the reliance

might find someone like Bill Gates. What we saw in Singapore, then, was a handshake between a stratum 5 and a stratum 8 head of state. And even if we apply a different mode than 8, the disparity in cognitive power still exists. How does a boy king deal with that disparity? If he were French (or maybe Canadian – smile), I would be looking for a high capability courtesan in his entourage – perhaps a Diane de Poitiers. As it is, there are a couple of senior advisors who are likely providing higher stratum guidance.

Vis-à-vis North Korea, the appellation "evil despot" would seem to be part of the job description. The characterization often comes up in relation to the disposition of enemies of the state – those that are involved in what we might refer to as treasonous behavior including fraternizing and sharing intelligence with foreign agents. North Korea is certainly not the only state to invoke a zero tolerance approach to espionage and sedition.

It is reasonable to assume that a boy king, almost two decades younger than the youngest U.S. president, initially relies on existing infrastructure for governance and survival and must tread carefully and patiently. Of course, there is the consideration that he may be mentally ill – in which case, SST and RO do not apply. Then, too, there is the old "-T/RB" factor. Perhaps an evil despot is simply someone unable to bring the required behaviors to the role.
